Paula -

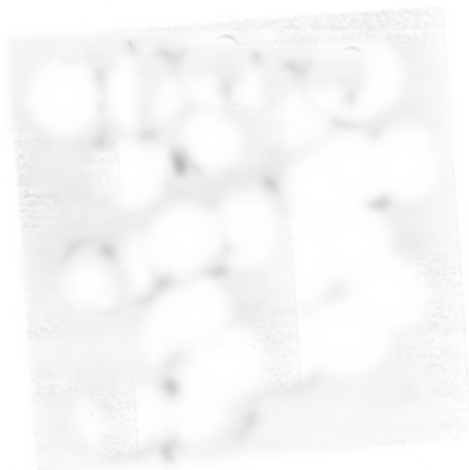
It has come to my attention that you are using the car. As you well know the car is not insured. I emailed you weeks back that you could not drive the car or have the car driven by someone else.
