I am writing to urge you to vote NO on HB 2576. I know that a select few agencies have come to the house and claimed they were being abused via the PRA, 90% of them are lying and I can prove it with just the public records I have so far.

The agencies who are crying the loudest are doing so because they are violating the public records act. I myself have been trying to get public records from the city of Everett since March of 2011 and they over charge me knowing I can't afford the records and then send me 107 of the same exact emails, or they claim I've abandoned my request, which is what the usual lie is. I have even received a disk with a virus on it, which the city tried to get back "so they could investigate it" but it has been handed over to a computer tech.

I now have a criminal record and am living like an animal because these people violated the PRA and my rights to the point that I have lost everything I have worked the past 15 yrs for, it is all gone, as is my reputation and my life's work. Not to mention I have had 2 major strokes because of the stress and because for the past 5 yrs I have had to decide whether to eat or get the records to try to clear my name so I am sick to the point that my thyroid is pretty much dead and I am 32lbs underweight.

Their actions are the cause of most of the litigation centered around the PRA, and 90% of the time the City of Everett attorney Ramsey Ramerman is involved and I have proof of Sara DiVittorio destroying public records and ordering others to do the same. I am not sure why no one seems to notice that it is usually the same 3 actors behind the whining and complaining.

Joe Beavers told a Seattle paper he just wasn't going to give Anne Block records that have been the focus of a major lawsuit on principle. In other words because of the advice of Ramsey Ramerman and Sara DiVittorio he feels he is above the law and above the will of the voters. So far the state has protected his criminal activities.

As an elected official some of you have hidden behind the Public Records Act or are undertaking this endeavor to protect your friends who are.

The *people* voted to enact the PRA and through this act I have found out about criminal acts perpetrated by our elected, county and city actors. All you have to do is take a look at my newspaper and you will see 100's of stories of wrong doing which you will be protecting by a "Yes" vote.

Most of the vexacious requestors are people who have tried 6 ways til Sunday to get even one single record, so they keep trying, they keep coming back, they keep begging for the records that are clearly theirs, yet the cities, counties, state legislature and the judiciary have somehow forgotten that they are accountable to us.

I have been working on gathering citizens and teaching them how to investigate the elected leaders all around this state, sadly there are many more, 100's more who have been abused by these same people and they are sick of it. We may not be able to stop you from violating our rights but we can definitely vote you out of office.

For those of you who still understand and respect the voters will: I would like to thank you in advance for your vote against this horrendous bill. You are the only protection we have from people like Beavers, Divittorio, and Ramerman. 75% of the money lost on lawsuits wouldn't even have to happen if these people just obeyed the laws.
